

NOTICE is further given that pursuant to Regulation 42(5) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and Section 91 of the Companies Act, 2013, the Register of Members and Share Transfer Books of the Company will remain closed from Saturday. September 14, 2019 to Friday, September 20, 2019 (both days inclusive) for the purpose of the AGM.

Pursuant to Section 108 of the Companies Act, 2013 read with Rule 20 of The Companies (Management and Administration) Rules, 2014 as amended from time to time and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Members of the Company holding shares either in physical or in dematerialized form as on "cut-off date" i.e. Friday, September 13, 2019, are provided with the facility to cast their vote electronically through E-voting services provided by CDSL on all resolutions set forth in the Notice of the 47th AGM. The Remote E-voting period shall commence on Tuesday, September 17, 2019 (9:00 A.M. IST) and ends on Thursday, September 19, 2019 (5:00 P.M. IST). The E-voting module shall be disabled by CDSL for voting thereafter. Remote E-voting shall not be allowed beyond the said date and time.

A person whose name appears in the register of Members / Beneficial Owners as on cut-off date i.e. Friday, September 13, 2019, only shall be entitled to avail the facility of remote E-voting as well as voting at the AGM and a person who becomes member of the Company after dispatch of the Notice of the meeting and holding shares as on the "cut-off date" may obtain User ID and Password by sending a request at <u>mobildc@yahoo.com</u>

A member may participate in the AGM even after exercising his right to vote through remote E-voting but shall not be allowed to vote again in the meeting. Once the vote on a resolution is cast by the Member by E-voting, he shall not be allowed to change it subsequently. In case the member's cast their vote by both the means then voting done through remote e-voting shall prevail and voting done through physical Ballot shall be treated as invalid.
